We are committed to protecting and respecting your privacy. This policy sets out the basis on which your personal data will be processed by Ulric of England. It is your responsibility to read the following carefully, understand our views and practices regarding how we will treat your personal data. Information we may collect from you

We may collect and process the following data about you: information that you provide by filling in forms on our site. This includes information provided at the time of registration or at the time of posting material if you contact us, we may keep a record of that correspondence; we may ask you to complete surveys that we use for research purposes although you do not have to respond to them; details of transactions you carry out through our site and of the fulfilment of any contract between us; details of your visits to our site and the resources you access.

IP Addresses and Cookies

We may collect information about your computer including, where available, your IP address, operating system, and browser type for system administration. This is data about our users' browsing actions and does not identify any individual. We will not collect information from you other than that provided by your browser in normal use. We may use cookies in our web site which contain information that is transferred to your computer's hard drive. They help us to improve our site and to deliver a better and more personalised service. They enable us: to estimate our audience size and usage pattern; to store information about your preferences and so allow us to customise our site according to your individual interests; to speed up your searches; to recognise you when you return to the Our web site. You may refuse to accept cookies by activating the setting on your browser, which allows you to refuse the setting of cookies. Where we store your personal data

Your rights
